Town Manager's Report

USDA Rural Development-Police Equipment and Garbage Truck

Joseph N. Quesenberry, Town Manager stated that a meeting with Tara Delany with USDA Rural Development was Tuesday and that we are making application for a \$25,000.00 Grant and Loan option for Police Equipment and a new Garbage Truck.

Gregory Packett has until July 1, 2018 to submit plans for the Warsaw Health Care Redevelopment that was purchased from the Town.

Banners have been ordered and will be installed tomorrow at 7:00 A.M. with the help of Northern Neck Electric Co-Op. The flags will go up by Memorial Day and we may need to replace a few of the damaged ones. The (18) Lights down Main Street are under VDOT review at this time.

The Saddlery contract has been signed by Gregory Packett to move and be done in a timely manner, working with Verizon and also Union Bank has contributed \$5,000.00.

We have gotten the first invoice for the Main Street DHCD Grant of a \$1,000,000.00 for \$4,000.00 for the architect.

The Warsaw Beautification Committee is working with Hurt & Proffitt.

The Gannon Project demolition is scheduled for 4:00 P.M. on April 25, 2018. Chief Joan Kent will be cooking hot dogs and hamburgers for the Love Sign Unveiling.

Police Report – Chief Kent

Joan N. Kent, Chief of Police stated she had been to training and that Officer Wendy McElroy had attended Child Safety Seat School. Chief Kent had been to a meeting at RCC and met with Tara Delaney on grant and loan monies for Police Equipment. There was a personnel meeting with the Police Department on Tuesday. Sergeant Eddie Headley and Officer Wendy McElroy attended Career Day at the Elementary School. The report of calls for March for the WPD was included in your council packages and any questions I will be glad to answer.

Planning Commission Report

Councilman Hamblin stated that what was discussed at out meeting was already approved in the Public Hearing.

Wastewater Treatment Facility Report

David L. Ambrose, Jr. stated that the average flow from Town was 171,800 gallons an increase of 7,100 gallons from February's flow average of 164,700 gallons. The max flow from Town was 218,500 gallons and increase of 24,900 from February's max flow of 193,600 gallons. The average total phosphorous for the month of March was 0.11mg/l which resulted in a monthly discharge of 3.9 lbs. This puts us at 11.6 lbs for the year. We are permitted 274 lbs. The average total nitrogen for March was 3.2 mg/l. This resulted in a monthly discharge of 117.0 lbs. This puts us at 362 lbs for the year. We are permitted 3655 lbs.

We had an air compressor fail at work for our filter system, we replaced the compressor with a spare that we had on hand for unexpected events like this. We have since ordered a new compressor to keep in stock.

We also completed normal maintenance on other equipment at the plant and had a random inspection from DEQ for the February reporting data and passed the inspection with no response needed to DEQ.

Northern Neck Regional Jail Report

Larry Thorn reported on the jail report which was in Council's packets for review. The total Population was 415 inmates and 134 were Federal inmates. By the end of the meeting the population was 433 inmates and 152 were Federal inmates. There was a nice dinner on the 4th of April and some council members made it and I do appreciate them being there. I would also like to get with the Town Manager before the next meeting on the NNRJ Budget.

Economic Development Report

Lee H. Capps, Planning and Economic Development stated there is a lot going on with businesses and business owners at this time I cannot go into but soon I am in hopes of being able to share with you all. There is a Façade Improvement meeting on April 17, 2018. Please make sure you are in Warsaw on April 25^{th} there are so many events going on starting with the Garden Club Tour , Demolition of the Gannon Property and then the Love sign unveiling.

Personnel Committee Report

Paul G. Yackel, Chairman stated that there was a meeting on Tuesday with the Police Department and how much they appreciated the support and also had concerns. There was a lot covered in this time and all council members are welcome to join the meetings and the next one is Tuesday at 4:00 the week of council meeting (May 8, 2018).

Ordinance Committee Report

Rebecca C. Hubert, Chairman stated there was a meeting on the Amendment on what was passed earlier in the meeting.

Mayor Phelps stated the Town Council election on May 1, 2018 needs to be talked up and out for citizens to be reminded of since there has been low turnout in the past.

Ogle E.
