### Manager's Report

John M. Slusser, Town Manager stated there will be a Warsaw Richmond County Main Street Program Annual Meeting on Monday, March 24, 2014 at 6:00pm at River Meadows and the Town Council was invited to attend. They would like input from the citizens and Town Council.

Also Council has been invited to the Northern Neck Regional Jail Board Nineteenth Annual Governing Bodies Recognition Dinner on Wednesday, April 2, 2014 at The Inn at Stratford Hall. There will be a social hour at 5:30 to 6:30 and then dinner at 6:30 and the attire is casual. There have been comments of the lack of interest from the Town Council in the past and I would encourage all to attend and the food is excellent.

John M. Slusser, Town Manager stated it is that time again to renew our Health Benefits and the forms need to be returned by April 1, 2014. This year the renewal calls for a 6.3% increase to the current program. The monthly rate per person would go from \$560.00 to \$595.00. After much discussion the council determined the increase was not a lot for the excellent policy the Town of Warsaw employees and retirees have had in the past. Councilman Yackel made the motion for the Town of Warsaw to stay with the Key Advantage Expanded Plan. Councilwoman Pierson seconded the motion. The following vote was taken.

Therefore, the Town would have their own program and add a line in the budget for the wildflowers and apply for the permit.

### Police Report

Chief Spare stated that the police report was in the council packet and if anyone had questions or comments he would be glad to answer. The next Triad meeting will be March 25, 2014 at Warsaw Baptist Church.

### Northern Neck Regional Jail

The Jail Report is in Council packet reported by Larry Thorn and the meeting was held on Wednesday, March 5, 2014. He stated the number of prisoners are down from 404 last month to 338 this month and there is a need for the Federal prisoners because they are the ones that pay the bills for the Jail. He suggested calibrating the water flow at the Jail and this would assure accuracy for the billings and usage by the Jail.

### Warsaw Planning Commission Report

Commissioner Washington reported at the Planning Commission's last meeting there were representatives from Helena Chemical that explained and answered a lot of questions from the commission.

### CUP REQUEST - RELISH AT RIVAHSIDE, INC.

### CUP REQUEST – RAPPAHANNOCK CHURCH OF CHRIST

Commissioner Washington stated that the Warsaw Planning Commission recommends to the Town Council a CUP Request of Rappahannock Church of Christ to obtain a CUP necessary to operate a church and related church uses, including but not limited to the operation of a cemetery as shown on the General Development Plan dated 1/23/14. The property is located on the northeast corner of Route 3 Bypass and its intersection with State Route 670 and is identified as Tax Map 24 Parcel 6A and recorded in Deed Book 272 Page 357. Councilman Forrest made a motion that the Rappahannock Church of Christ CUP approval of application to operate a church and church related facility, including cemetery on Tax Map 24 Parcel 6A. Council requests that the Church work together with the Town on a Utility Easement for sewer in their Final Site Plan submission. To avoid misunderstanding, there are no requirements for additional submissions to begin the cemetery construction and use. Councilman Washington seconded the motion. The following vote was taken.

### AMENDMENT TO DEVELOPMENT MANAGEMENT ORDINANCE

John M. Slusser stated this was mandatory and was required by the Commonwealth of Virginia.

## SECTION 2-2-15 SEPTIC PUMP OUT REQUIREMENT NOTATION ON PLATS

No final approval will be granted until a notation is made upon all plats to be recorded that septic pump out certification is required every five (5) years in such form as required by the Town of Warsaw. The notation may include the statement that lots connected to sewer that do not contain a functioning septic system are exempted so long as that remains the case.

## SECTION 2-2-16 RESOURCE PROTECTION AREAS AND RESOURCE MANAGEMENT AREAS TO BE IDENTIFIED

No final approval will be granted unless Resource Protection Areas (RPAs) and Resource Management Areas (RMAs) are clearly depicted on all plats to be recorded or final site plan reviews. If no RPA or RMA exist on the property, a notation indicating such shall be made.

Councilman Yackel made a motion for the amendment to the Development Management Ordinance as stated above for Section 2-2-15 & Section 2-2-16. Councilwoman Pierson seconded the motion. The following vote was taken.
